**TRANSPORTATION MONTHLY FEE**

The Vacaville Neighborhood Boys & Girls Clubs provides transportation for Club member's from their school site to the Trower & Acacia Clubhouses. The cost of transportation is an additional monthly fee of \$30 per student. All payments are due on the Wednesday prior to the week of pickup.

**STUDENT TRANSPORTATION EXPECTATIONS**

1. Use appropriate language in the van.
2. Approach van once it has stopped.
3. Members must fasten their seat belts.
4. Remain seated at all times.
5. Always keep the aisle clear.
6. Treat everyone with respect.
7. Follow directions given by the van driver.
8. Members are not to distract van driver.
9. Keep all body parts inside the bus/van.
10. Members may not throw items out of windows.
11. Eating or drinking is not allowed on the van.
12. Sharp/dangerous items are not allowed in van.
13. All members must wait at their school for pick-up.

**EXPECTATION INFRACTION FEE**

Members who do not follow the directions of The Vacaville Neighborhood Boys & Girls staff or fail to comply with established rules may lose transportation rights, membership privileges, or incur an additional transportation fee of no more than \$10 per infraction. Example, eating and missing the van will be an automatic \$10 fee upon monthly renewal of transportation.
